The Institution agrees to publish this overall strategy on its website within one month after the signature of the Erasmus Charter for Higher Education by the European Commission.

The European University of Rome is a private, legally recognized, Catholic University which is part of a huge network of universities (Red Anáhuac), held by the Legionaries of Christ and widespread in many countries throughout the world. The international focus is therefore part of the University's history. Our students have the opportunity to spend a period of study, being able to count on the collaboration between different universities to facilitate as much as possible mobility.

The European University of Rome focuses all its attention in training students both personally and culturally. It focuses on teaching the meaning and importance of life which will then reflect in both the human and Christian existence of the students in their future.

In this context, the University ensures that for each degree programme:

- Proposes and coordinates programs to promote excellence and encourage the education of students with strong academic performance and top quality human resource abilities;
- Offers a tutoring service to guide the choices and to develop effective study skills;
- Organizes extra-curricular activities in the social, cultural, artistic, sports, tourism, entertainment, publishing and multimedia;
- All courses provide a solid education to students so that they may fit into the professional world with valuable knowledge and strong management skills.

The Center for International Relations Departmental deals specifically to expand the opportunities for exchange students and teachers and to achieve the objectives of the European Union in the field of education, training and institutional development.

The Center for International Relations departmental support international mobility for students and teachers, academics and logistical aspects of managing the period of study and/or lecturing abroad and taking care of the reception of students and faculty foreign guests of the UER.

Mobility, characterized by full recognition of the program of study undertaken abroad, place both within the EU's Erasmus program/Erasmus + through bilateral agreements with non-European universities.

The Centre collaborates with the departmental Job Placement Center to provide students, undergraduates or graduates UER , opportunities for international internships at prestigious institutions and/or foreign companies, with particular attention to the possibilities offered by companies or training centers and research within of the Erasmus Programme / Erasmus +.
