 Program: This project aimed to test the moderating role of the need for cognitive closure in the perception of leadership fairness.

We hypothesized that NFC enhances the prejudice towards female managers because of the stressed perception of the incongruity between the prototype of leadership (agency, power characteristics) and the stereotypes of women (communal, warmth characteristics).
