Bachelor's degree Program in Business

Overview:

The Double degree program results from a cooperation between Università Europea di Roma (Italy) and Dublin Business School (Ireland).

It is a 1st cycle degree program (bachelor's degree/ laurea triennale) in Business Management.

The program permits the student to attend the last year of the bachelor's degree at DBS. As result, the student will be granted two degrees:

- ❖ Bachelor's degree in Business Management (L-18), from Università Europea di Roma
- ❖ Bachelor's degree in Business from Dublin Business School

Participating in this program the student will earn two degrees in less time than what would be necessary to complete the two programs separately.

The program is structured as follows:

- ❖ The first and second years are carried out at Università Europea di Roma
- ❖ The third year is carried out at the Dublin Business School

Admission

Each academic year, 3 students enrolled in the third year of the bachelor's degree in Business Management at UER can take part in this double degree program. Details regarding the application procedure, the selection process, deadlines, and further information will be specified in the call for applications. The minimum requirements are:

- ❖ 120 ETCS acquired before the application deadline.
- ❖ IELTS certification of 6. If the student gets 5.5 he has to do an integrative intensive course of English at the Dublin Business school. Its cost is included in the fee.

Tuition Fees

Students enrolled in the double degree program will pay tuition fee only to Università Europea di Roma plus a Graduation fee of 3000€ to the Dublin Business school
