







CALL FOR PARTICIPATION IN THE MOBILITY PROGRAMME - BIP (BLENDED INTENSIVE PROGRAMME) "TRANSNATIONAL LITIGATION (MOOT)" - ERASMUS+ PROGRAMME FOR STUDENTS OF THE MASTER'S DEGREE IN LAW, ENROLLED IN THE 4TH AND 5TH YEAR DURING ACADEMIC YEAR 2023-2024

1. PURPOSE

The purpose of this call for proposals is to define the conditions under which students of the Università Europea di Roma may participate in the BIP (Blended Intensive Program) "Transnational Litigation (MOOT)" mobility programme, which is among the novelties of the Erasmus+ Programme, with the aim of combining physical mobility with virtual and distance activities.

In this way, students from different European universities receive an educational experience through telematic collaboration between academic institutions, culminating in a short mobility at one of the partner universities.

This exchange will be carried out with the aim of academic recognition and achievement, as well as to match the student's curricular profile. Students are encouraged to participate in Pax MOOT 2024, but the two projects are distinct, and it is not mandatory to take part in both.

Everything that is not regulated by these terms and conditions will be governed by the European provisions for the Erasmus+ Programme and the General Mobility Regulations of the Università Europea di Roma.

2. ELIGIBILITY REQUIREMENTS

The eligibility requirements for student mobility will be the following:

- Be enrolled in the 4th or 5th year of the Master degree in Law at Università Europea di Roma, during the academic year 2023/24.
- Be a national of one of the countries participating in the Erasmus programme or be recognised by the country in which the student resides as a refugee, stateless person or permanent resident
- To prove knowledge of English at level B2 of the Common European Framework (CEFR).

Previous Erasmus students:

They will not be able to exceed, once the duration of the physical stay requested in this call is added up, the maximum time of 24 months allowed by the Erasmus+ programme for the corresponding cycle of studies- degrees that give access to doctoral studies (Law).

In the event of a tied score, applications received from students who have not been already assigned an Erasmus+ study or internship mobility will have priority.

3. PLACES OFFERED AND PERIOD OF LENGHT

Six (6) places are offered to participate in the BIP (Blended Intensive Program) "Transnational Litigation (MOOT)"

The structure of the programme is attached in Annex I of this call. It is integrated into the academic calendar 2023/24 as follows:

- 8 weeks of online training between February and March 2024.
- 5 days of mobility for face-to-face training at the Università Europea di Roma (Italy) in April 2024.

4. SUBMISSION OF APPLICATIONS

Applicants must submit their application exclusively through the application form available on the UER website at https://www.universitaeuropeadiroma.it/internazionale/#tab summer-schools and submit it by **January**, **24**th **2024**:

- a) by direct delivery to the International Relations Office (C108, 1st floor, corridor C), during reception hours;
- b) by e-mail to elena.lecci@unier.it.

The application must be accompanied by:









- a curriculum vitae
- a self-certification of enrollment with the updated status of the student's career extracted from the Esse3 system: the list of examinations taken, relative marks and CFUs acquired
- copy of a valid identity document;
- valid English B2 certification (i.e. First Certificate, IELTS, TOEFL, etc.).

Applications received after deadline that are incomplete or incorrect will not be taken into consideration.

The list of successful candidates will be evaluated by an appointed Commission and published on the UER website by January 22^{rd} , 2024.

By January 25th 2024 the successful candidates must send a statement confirming their participation in the BIP by e-mail to elena.lecci@unier.it.

Candidates who do not wish to participate in the BIP project, will have email the same address within the above-mentioned deadline.

5. SELECTION CRITERIA AND RANKINGS

Eligible applications will be evaluated according to the following criteria

- up to 60/100 on the basis of the sum of the weighted average and the percentage of the total credits accumulated in relation to the semester (credits obtained ÷ credits to be obtained, within the semester of reference for each student, x 30)
- up to 10/100 for the level of knowledge of the English language, awarded as follows: 3/100 for level B2, 6/100 for level C1, 10/100 for level C2.

6. PRE-DEPARTURE MEETING

The acceptance of the assigned Erasmus mobility place implies the commitment of the student to compulsorily attend the Pre-Departure Meeting to be held at the Università Europea di Roma before the physical mobility. The exact date will be communicated by the International Relations Office to the student's e-mail account.

Students will proceed to read and sign the documents requested by the Erasmus+ programme, following at all times the instructions provided by the International Mobility Office and published on the UER website (Financial Agreement, Validation Agreement, Learning Agreement, Certificate of Stay...).

7. STUDENT RESPONSIBILITIES

- A) Students will be responsible for finding and booking their accommodation and for managing the documentation required by the BIP Erasmus+ exchange programme.
- B) Students will be obliged to attend the Pre-Departure Meeting.
- C)Students will contact the coordinator of the programme at UER (Prof. Aniello Merone aniello.merone@unier.it) in order to manage the Validation Agreement prior to the programme. This agreement will define that UER is subject to recognise, once the BIP course has been successfully completed and passed, student participation with a teaching load of at least 3 ECTS. The template will be sent directly to the student's e-mail account.
- D) Students must complete all official documents of the Erasmus+ programme, following the indications provided by the International Relations Office. The documents template will be sent directly to the student's e-mail account.
- E) They will obtain a European Health Insurance Card or private health insurance covering the entire duration of the physical stay in Rome Italy (host country).

Failure to comply with the terms and conditions of the call for applications as well as the concealment of data, failure to submit documents, lack of acceptance, alteration or manipulation may be grounds for rejection or cancellation from the exchange programme.
